By-Law Update Committee

Chair, Dee Hart. The final corrections to the by-laws were sent to members' email. Dee will go over the standard operating procedures and make additions and corrections after the quilt show. Dee made a motion to

accept bylaws, seconded by Lynn Stiles, all approved.

Bonding

Margie Hoffmaster and Lois Dunn met with Bridgett Cutlip at State Farm Insurance to discuss fidelity coverage for the guild. Two kinds of policies are available. One is scheduled where only specific, named members are covered. The second is blanket coverage which covers all of our members. We decided that blanket coverage will suit our needs since several people may handle money before it reaches the treasurer. It was determined that \$25,000 coverage is sufficient for our needs. The policy is \$86 a year with a \$250 deductible. This policy only covers intentional losses (embezzlement). The guild must notify State Farm with the change of officers. Mary Durkin made a motion to approve and it was seconded by Kathy Strelko, all approved.

UFO Challenge

Mary Durkin explained that your UFO needed to be started as of the August 2018 meeting. When your UFO is finished you can write it on the list that Mary will bring to each meeting. The challenge will end August 2019.
